- diagnose the health problems of the child and its parents,
- assess the general condition, efficiency of respiratory and circulation systems and the state of hydration of the child,
- assess the nursing problems, elaborate the nursing procedures and take care of the sick and healthy child,
- · assess the state of nutrition and level of nutrition disorders,
- maintain nutrition of the sick and healthy child,
- keep controlling the functioning of the child's basic body systems and organs,
- assess health risk on the basis of disorders of the basic body systems and organs,
- recognize the state of immediate health risk to the child,
- choose and apply the optimal method of preparing the child to the diagnostic and therapeutic treatment.
- administer medicines to the child,
- recognize pain and cooperate in the painkilling procedure,
- work with the therapeutic team,

#### Tasks of the trainee:

### 1. Documentation procedures and the organisation of work in the warm

#### The trainee will:

- learn the organisation structure and specific character of work in paediatric ward,
- learn the medical documentation and computer system of the ward,
- assess the children's general condition on the basis of:
- ✓ the state of consciousness,
- ability to see and hear,
- child's behaviour, reaction for orders and requests,
- ✓ psychomotor development,
- ✓ vital signs,
- ✓ skin condition,
- the body posture (height, body mass, etc.),
- plan an appropriate diet for the child at its specific age and health condition.

#### 2. Nursing procedure preventing the child from hospital infection in the paediatric ward

#### The trainee will:

- · learn procedures in the paediatric ward,
- apply the rules of aseptics and antiseptics ,
- apply the following procedures:
- ✓ washing hands hygienically,
- using antiseptic means in surgeries,
- ✓ segregation of medical waste in the paediatric ward,
- transportation and storage of potentially infectious material,
- using disinfection means on various surfaces,
- sterilisation of equipment used in the paediatric ward,
- procedure after explosion caused by infectious materials,

#### 3. Pharmacological treatment

#### The trainee will:

- explain to the child and its carers the rules of the 24-hour intravenous administration of liquids and medicines,
- inform the childs carers about the planned treatment,
- · perform the appropriate calculations to dose the medicine,
- prepare the appropriate dose of the medicine and apply it through a vain, muscles, bronchi, nose, mouth, anus, tongue, on to the skin and mucosa,
- use central venous catheters and circular venous catheters,
- use infusion pump,
- explain the rules of applying a medicine to its parents, depending on the individual treatment plan of the child.

#### 4. Diagnostic of children's illnesses

#### The trainee will:

- take part in the examination in the paediatric ward,
- inform the child's carers and prepare the child to the medical examination,
- · accompany the child and observe the medical examination,
- · take care of the child after the examination,
- obtain samples for the biochemical and microbiological examination.

## 5. Nursing care of the child with disorders of various systems

#### The trainee will:

- take part in the process of diagnosing the child,
- use appropriate rules during various medical treatments,
- observe and record the general condition of the child,
- · take part in the planning of the child's rehabilitation,
- · help the child with everyday activities depending on its clinical condition,
- cooperate with the child's carers and prepare them to nurse child,
- prepare the family to take part in the process of the child's rehabilitation during its stay in the hospital and at home,
- help in creating the atmosphere encouraging the child to overcome difficulties in the process of rehabilitation,
- help child to overcome the fear of rehabilitation and diagnostic activities.

## Monitoring and evaluation plan:

#### MONITORING

Monitoring activities of the sending institution

- every Monday: an e-mail from the trainee with a short report (an electronic version of the monitoring form will be sent before the departure of the trainee),
- at the end of the first month: monitoring visit of Home University representatives.

#### Monitoring activities of the tutor from the host institution

- everyday monitoring of the trainee work and verbal feedback at the end of each day,
- after the first, second and third month of the placement: e-mail from the tutor with a short report (monitoring form will be agreed before the trainee's arrival).

#### **EVALUATION**

Evaluation activities by the tutor from the host institution: preparing the Transcript of Work at the end of the placement, including an evaluation of the trainee's performance of essential tasks (detailing knowledge acquired by her, the trainee's attitude toward work, social skills, personal qualities etc.).

## Evaluation activities of the sending institution:

- preparing a final evaluation report on the basis of all monitoring and evaluation activities and reports and Transcript of Work from the host institution,
- recognition of the placement by the deputy dean responsible for placements.
